Rules for undergraduate Boys' Hostels

All residents of Boys Hostel should abide by the following rules:-

- 1. Ragging is completely banned. All the students are advised to reframe from such activities. Any Violation of this by the students will be dealt with very severe punishment.
- 2. All students are requested to maintain the code of conduct and behave courteously and fairly with everyone.
- 3. All residents should enter the Hostel before 9:00 pm everyday and sign the hostel register.
- 4. If some students have to stay outside the hostel during night or go home of some other places due to unavoidable causes, they must have to take prior permission from the Hostel authority. (Except the ward duty).
- 5. All boarders must have to join the mess and the mess dues should be paid within the 1st week of every month.
- 6. Meals should be taken in his dining hall not in the room. Plates should not be kept in his Verandah.
- 7. They must ensure that lights and fans in his room are switched off when the rooms are not occupied.
- 8. Cooking in the hostel rooms and use of heater, gas, microwave oven, refrigerator etc. are not allowed and it is punishable.
- 9. Guests in the hostels are not allowed (if emergency situation guest stay in the hostel, they should take prior permission from the Hostel authority, and guest have to submit I.D. proof. The guest charges are to be borne by the student.
- 10. Timing for visiting hours for guest is 12 noon to 1 PM & 4 PM to 6 PM.
- 11. Only authorized dhobis, barbers & tailors will work in the hostel premises.
- 12. No gathering of residents for political purpose is allowed inside the hostel.
- 13. Permission from the authority must be taken to organize any functions in the hostel.
- 14. All students have to keep their allotted room neat and clean as well as the hostel campus and surrounding and should not throw litter indiscriminately.
- 15. Smoking / Chewing Tobacco / Gutkha / consumption of alcoholic drinks / narcotic drugs is strictly prohibited.

Rules for Girls' Hostels

All residents of Girls' Hostel should abide by the following rules and regulations: –

- 1. Ragging is completely banned. All the students are advised to reframe from such activities. Any Violation of this by the students will be dealt with very severe punishment.
- 2. All students are requested to maintain the code of conduct and behave courteously and fairly with everyone.
- 3. All residents should enter the hostel by **6:00/7.00/8.00** PM everyday and sign the hostel register.
- 4. If some students have to stay outside the hostel during night or go home of some other places due to unavoidable causes, they must have to take prior permission from the Hostel authority. (Except the ward/ department duty or clinics postings)
- 5. All boarders have to join the mess and the mess dues should be paid in full irrespective of any leaves or holidays availed. The mess dues must be paid within the **1st week** of every month.
- 6. Meals should be taken in his dining hall not in the room. Plates should not be kept in her verandah.
- 7. They must ensure that lights and fans in his room are switched off when the rooms are not occupied.
- 8. Cooking in the hostel rooms and use of heater, gas, microwave oven, refrigerator etc. are not allowed and it is punishable.
- 9. Guests in the hostels are not allowed (if emergency situation guest stay in the hostel, they should take prior permission from the Hostel authority, and guest have to submit I.D. proof. The guest charges are to be borne by the student.

10. Timing for visiting hours for guest is 12 noon to 1 PM & 4 PM to 6 PM.

- 11. Only authorized dhobis, barbers & tailors will work in the hostel premises.
- 12. No gathering of residents for political purpose is allowed inside the hostel.
- 13. Permission from the authority must be taken to organize any functions in the hostel.
- 14. All students have to keep their allotted room neat and clean as well as the hostel campus and surrounding and should not throw litter indiscriminately.
- 15. Smoking / Chewing Tobacco / Gutkha / consumption of alcoholic drinks / narcotic drugs is strictly prohibited.
